## Air Conditioning Rebates and Financing for ACE Customers

**Rebates up to \$1,000\* and Financing up to \$15,000\* when paired with a Natural Gas Measure**

Upgrade to qualifying equipment and you may be eligible for rebates, including up to a \$1,000\* rebate for the highest efficiency air source heat pump (see chart below), as well as incentives from New Jersey Natural Gas (NJNG), including 0%\* APR financing through NJNG's On-Bill Repayment Program (OBRP). Replace what you need now and return later to access even more rebates and incentives for additional equipment upgrades. Enhanced rebates and financing options are available for income-eligible customers.

Air source heat pump Tier 2 (SEER ≥ 18, EER ≥ 13, HSPF ≥ 10) OR (SEER2 ≥ 17.1, EER2 ≥ 11.7, HSPF2 ≥ 7.8)	\$1,000*
<b>Ductless mini-split heat pump:</b> Single: (SEER ≥ 20, EER ≥ 12.5, HSPF ≥ 10) OR (SEER2 ≥ 20, EER2 ≥ 12, HSPF ≥ 9) Multi: (SEER ≥ 18, EER ≥ 12.5, HSPF ≥ 10) OR (SEER2 ≥ 18, EER2 ≥ 12, HSPF ≥ 9)	\$400
Ductless mini-split air conditioning (SEER ≥ 20, EER ≥ 12.5)	\$500
